Scheduling a Capitol Hill Visit - 2023

How to Contact your Members of Congress

- Find your Representatives and Senators by going to the following links:

 - Senate:

- As an alternative, you may call the Capitol Hill switchboard at 202-224-3121 and ask to be connected to your House Representative or Senator's office.
- Prior to the meeting, it is advisable to familiarize yourself with the issues that are
 important to the Member by visiting his/her website and social media accounts.
 Knowing the issues supported or opposed by the Member makes a favorable
 impression on them.
- Show that you have researched the prevalence of lung disease in the Member's district, for meetings with Representatives. State statistics are available for Senators. See below.

Ways to Schedule a Visit with the Member

- Allow as much lead time as possible to schedule a visit since schedules will fill up quickly.
- Contact may be made by phone or email. One the AARC PACT Connects site we have posted a list of Congressional Schedulers for each office. They are important in obtaining a meeting directly with a member of Congress.
- We recommend sending a meeting request by email because of the high volume of calls received on Capitol Hill. We recommend including "Constituent Meeting Request" as the subject for your email if you live in the Congressional District. If this is not a constituent meeting the subject line should be Meeting request to discuss respiratory therapy and patient needs.
- Once the initial communication is sent, we recommend following up by phone if you do not receive a response.

Provide Background

• Let them know that the AARC advocates for legislation and other issues important to

the respiratory profession and to patients suffering from chronic respiratory disease.

- Highlight that you have been appointed by your state society leadership to represent the society, respiratory therapists in your state
 - o If you are from the House Member's district let the staff person know this.
 - The number of RTs in Alaska can be estimated since the state does not require licensure.

What You Want to Discuss

- You are requesting a brief meeting to discuss:
 - Improving patient access to pulmonary rehabilitation programs and respiratory therapists who are essential members of the multi-disciplinary team.
 - We want Congress to take action to reform Medicare Home Oxygen Payment to improve patient outcomes and recognize the need for respiratory therapists to provide care.
- Let the Member's staff know you will forward background information for the meeting as soon as it is available.
- Ask for a morning or afternoon appointment and let the staff pick the time. Plan on the meeting lasting around 15 minutes.
