Due to the facility's limited storage, AARC will be working with a 3rd party drayage company to handle off-site storage of all exhibitor freight. Show Management will provide additional details closer to show dates.

The AARC will not be responsible for any lost, stolen, broken, etc. materials or equipment belonging to exhibitors.





SET-UP TIMES FOR EXHIBITORS

Saturday, July 13 – 3:00pm - 6:00pm

Exhibitors are encouraged to check in on Saturday afternoon at registration to avoid long lines.

DISMANTLE TIME FOR EXHIBITORS

Monday, July 15 – 4:00pm - 5:30pm

All exhibitors and their materials must be cleared no later than 6:00 pm. **Early teardown is not allowed without prior approval from Show Management.**

SUMMER FORUM EXHIBITS

The exhibits will be open on Sunday, July 14 and Monday, July 15. The exhibit area will be located around the educational sessions and in the foyer areas at the resort. All booths must be staffed during the dedicated Exhibitor break times. We encourage exhibitors to be at their tables during the lunch/ afternoon breaks to increase your visibility to attendees.

Each company is allowed **ONLY two (2)** representatives at their table due to space limitations. The two (2) representatives may earn CRCE credits for lectures attended if they are AARC members. A CRCE form will be sent to exhibitors prior to Summer Form for completion to ease the CRCE claim process.

"No show" exhibitors risk being banned from exhibiting at Summer Forum in the future.
