

Background on Supplemental Oxygen

Why is Supplemental Oxygen So Important?

- Important treatment for patients with lung disease and heart disease
 - Advanced COPD
 - Pulmonary hypertension
 - Pulmonary fibrosis
 - Patients awaiting lung transplant
 - Other restrictive lung diseases including LAM, PCD and sarcoidosis
 - Congestive heart failure
- Research shows providing supplemental oxygen improves patient outcomes

How Did Access Get This Bad?

- Process for Medicare to set prices for medical equipment, including oxygen, based on bids submitted by companies – dropping everything to the lowest bidder.
- This resulted in pricing and availability challenges that made it difficult for many people to access oxygen equipment, particularly liquid oxygen, as vendors discontinued services.
- The lack of funding also led oxygen suppliers to stop providing RT services.



What Needs to be Fixed?

 People are stuck with heavy systems that limit or completely prevent them from leaving their house and being in the community.

This is not a portable system!



What Needs to be Fixed?

 Some may sacrifice appropriate oxygen flow - literally starving themselves of oxygen so they can be outside for brief periods to complete simple tasks like buying groceries.







High Flow

Liquid Oxygen – What Is It?

Liquid oxygen is a lightweight, high flow modality of oxygen. It can allow people who need high-flow oxygen to leave their homes comfortably and safely

Liquid Oxygen - Issues with Access

- Liquid oxygen users dropped by approximately
 80% in the first few years of competitive bidding.
- Physicians prescribe liquid oxygen less often because of difficulties with access. Newer physicians may not realize they can prescribe it, and most of the US does not have liquid oxygen available.
- When liquid oxygen *is* prescribed, patients have significant challenges in receiving it. Some have been removed involuntarily from liquid.



Access to Respiratory Therapists

- Respiratory therapists are trained to help patients use their oxygen appropriately and ensure that it is properly calibrated to their needs.
- As oxygen reimbursement has decreased, companies have stopped offering access to respiratory therapist services to patients who need supplemental oxygen.

 Ensure supplemental oxygen is patient centric:
 Create a patients' bill of rights to ensure care is focused on patient needs

Who Am I Calling and Why??



Calling is one of the most powerful ways to put pressure on your representatives – even more than social media, email, and especially snail mail.

Why?

It shows commitment to a cause. And representatives know that if they don't hear the concerns of their constituents, it could impact their ability to get reelected.

Phone Call Tips/Preparation

- Record questions for follow up.
 - Most of the time they will just tell you they will pass on your concern. They might read
 a prepared statement in response. They might even say that your rep is going to/not
 going to take action.
- Fill out the follow-up form that you've been emailed to let us know what your lawmakers say.
